August 4, 2022 Election Date Announced

- Government of Nepal announce that elections for HoR and Provincial Assembly to be held on November 20, 2022
- Registration for new voters stopped

September 17-31, 2022 Proportional Representation(PR) Submission Timeline

September 17-18: PR Closed-list submission period September 18-24: Closed-list correction period September 25-31: Updated closed-list

November 3-17, 2022 Election Campaign Period

Candidates are allowed to run their election campaign between Novermber 3 and 17

November 18-19, 2022 Silence Period

Candidates are not allowed to do any publicity or campaigns during this period




October 11: Candidate name-list publication October 12: Candidacy withdrawl period, final list publish and election symbol distributed for candidates

Proportional Representation (PR)




Distribution of seats corresponds with the proportion of the total valid votes cast for each party

Proportional Representation Mechanism

Nepal is considered a single constituency and vote is given to parties. Percentage of valid votes received by parties is the percentage of seats they receive.

For Provincial Assembly, a single province is considered as a single constituency. PR seats are constituted by 40% of the total members of the Provincial Assembly .



PR Seat Distribution Example

Madhesh Pradesh has 32 HoR constituencies. Since each HoR constituency is divided into two provincial consitutencies, there (32x2) 64 provincial constituencies. One candidate is elected from each provincial consituency for a total of 64 members, which is 60% of total Provincial Assembly members of that province.

64 members is 60% of 107 members. The rest 40%, which is 37 members, are elected through PR.

Ballot Papers

165 for federal FPTP* constituencies + 330 for provincial FPTP constituencies + 7 for candidates contesting under PR* for seven provinces + 1 for federal PR candidates

503 Types

Each Voter Will Cast Four Votes

- 1. House of Representative FPTP Candidate
- 2. House of Representative PR
- 3. Provincial Assembly FPTP Candidate
- 4. Provincial Assembly PR

Ballot papers will only include election symbols of candidates and parties contesting in the election from each constituency
